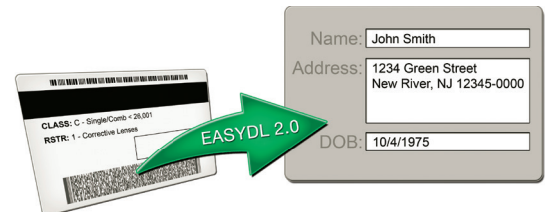
## TotalFreedom Plug-In

Honeywell's EasyDL™ 2.0 software plug-in parses bar code data found on US and Canadian government-issued driver's licenses, identification cards, and U.S. military ID cards for applications involving age verification or automatic electronic form population.

Powered by Honeywell's TotalFreedom™ open-system architecture, which was created to enable development for Honeywell area-imaging scanners, EasyDL 2.0 eliminates the need for host system software to process the encoded information contained within the barcodes on documents such as driver's licenses and state and military-issued identification cards.

EasyDL 2.0 can be purchased pre-installed on the Xenon family of scanners and also on Voyager® 1400g2D and 1400gPDF area-imaging scanners. It can also be purchased as a standalone upgrade that can be added to Vuquest™ 3310g, Stratos™ 2700, Genesis 7580g, as well as on pre-purchased Xenons or Voyager 1400g units. Our easy-to-use configuration utility enables users to transmit any of the available data fields in any order chosen. The fields can then be separated by selecting any of the available delimiters, to provide the desired output format.

Enhancing Honeywell's barcode scanners with EasyDL 2.0 is an ideal solution to improve accuracy, increase efficiency, and reduce the liability involved with selling age-restricted products.

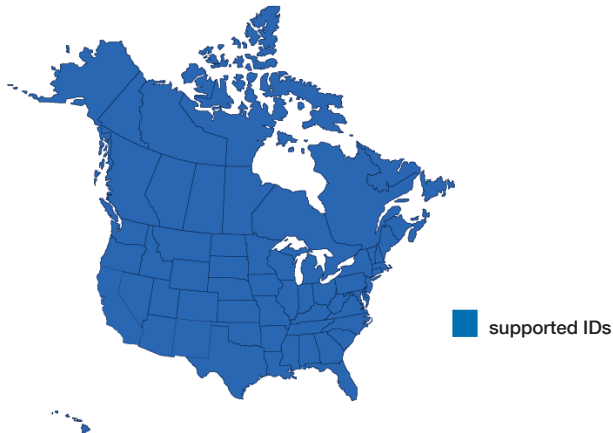
